	7	provided any benefit of any kind to A, any public representative, B, any public
	8	official by or through Frank Dunlop and/or other intermediaries.

12:06:25	10	The only dealings I had with Frank Dunlop related to Mr. Dunlop, being the
	11	Department of Transport in respect of the upgrading of a right-of-way owned by
	12	the Department, at lands at Dublin Airport.
	13	
	14	The upgrading of this right-of-way was agreed in principle in October '93 and
12:06:39	15	Mr Dunlop was paid a fee of 3,000 pounds. I am now retired travelling through
	16	Europe with ultimate destination Australia for the Olympic games. Should you
	17	wish to contact me further please write care of address in London. I am in
	18	regular contact with the person identified and he will ensure that I receive
	19	details of any correspondence.

21	am I in regular contact with him. I have never met Mr. Mahony. I may have met
22	Mr. Fox once. I did not have any dealings whatsoever with either of them. I
23	do not know that they had lands rezoned or what that when that rezoning took
24	place. I did not at any time speak to Frank Dunlop regarding lands at Drumlish
12:10:37 25	nor have I had any idea why Mr. Dunlop is trying to involve me in this. As I
26	have already told you I asked Mr Frank Dunlop to assist in obtaining an upgrade

14	was completed in the 1995.

16	I canvassed Mr. GV Wright on a number of times in 1992 and 1993 to obtain
17	support for our project. I also canvassed most of the other councillors. None
18	of them asked me for money. Almost all agreed to support our motion. That is
19	all I know of these events. I can be of no further help. I regret the hurried
12:46:49 20	nature of this letter but I am leaving the Island tomorrow for about four weeks
21	and you did request an urgent reply.
22	
23	Now, that letter was acknowledged on the 18th of November '93. At 579.
24	
12:46:50 25	And then at 580 on 27th of January 1994 Mr. McGuinness was again written to by
26	the Tribunal in relation to these lands.
27	
28	I note from my recent review of your file that my colleague Ms Gilvarry wrote
29	to you on the 7th of November 2003 seeking a further more detailed narrative
12:46:55 30	statement in relation to the above lands. I enclose herewith a further copy of

2	you reply to same as soon as possible and in any event no later than the 10th

12:46:56 5	And on the 11th of April 2004 at page 581/582 of the brief, a reply was
6	received to that letter and the letter of the 7th of November which I referred
7	to earlier and which is at page 569.
8	
9	I have just received your letters of the 27th of January and 17th of November,
12:46:56 10	2003. Please note that this is the first time I have received your letter of,
11	in fact I think that should be the 7th of November 2003.
12	
13	I have already given you most of the details you request.
14	
12:46:57 15	A, lands were purchased circa 199, we attempted to have them rezoned by way of
16	Section 4 but could find no support. We were advised to seek rezoning under
17	the 1993 Development Plan. The lands were rezoned in March 1993 and the
18	rezoning was confirmed in September '93.
19	
12:46:57 20	I met Mr. Dunlop in February/March of 1993. At this time we already had the
21	support of all political parties for the rezoning. We had a general discussion
22	regarding the lands. I told Mr. Dunlop that all of the parties were supporting
23	but that we were having difficulty which I did not understand with the
24	Department of Transport regarding the upgrade of our right-of-way. Mr. Dunlop
12:46:59 25	said he knew this Department very well and could help. At a later meeting in
26	his offices Mr. Dunlop told me that the Department would not enter into
27	discussions until the rezoning of the lands was confirmed in September, at the
28	meeting we discussed fees.
29	
12:46:59 30	Mr. Dunlop asked for a figure which I said was way too high. We finally agreed

12:46:59 1	3,000 pounds and was paid in cash. The rezoning was confirmed in September.
2	We paid Mr. Dunlop and entered discussions with the Department of Transport.
3	C, we began discussions in September 1993. Professionals were finally
4	approached by both sides and agreement was reached in '94 beginning of '95. I
12:47:01 5	cannot remember dates of meetings. As far as I'm aware the final contact was
6	not, contract was not issued as late as 1997 although the fee was paid in circa
7	1995. If Mr. Dunlop has retained his files he will have copies of the various
8	letters etc.
9	
12:47:01 10	D, I was MD and majority shareholder in Neptune Freight. I did not have any
11	discussion with anybody else in Neptune. That was my sole response. I did not
12	need anyone's approval.
13	
14	E, I had one meeting with the local authority official shortly after buying the
<i>12:47:02</i> 15	lands. My memory of that meeting was that I was told that the lands would be
16	developed but that they were with Aer Rianta's area of influence I thought this
17	was very high handed.
18	
19	F, as I already explained Mr. Dunlop asked for cash. I paid him in September.
12:47:02 20	When we entered discussions with the Department of Transport I converted
21	foreign currency I'd had from my many business trips abroad to make this
22	payment. Again, I did not need to meet with anybody from Neptune.
23	
24	I am sure Mr Dunlop's paperwork will show that he continued to advise us on the
12:47:03 25	right-of-way problem through 1994 and early 1995. I am sure you will
26	understand Mr. Dunlop did not work for nothing.
27	
28	As he did not ask for and nor was he given any further payment the only
29	presumption can be that the payment made to him was for the work and not for
12:47:04 30	bribing politicians. A glance at the votes on rezoning will show as I said all

12:47:04 1	parties supported the motion. I am also sure that every politician I met will
2	tell you that I argued for the rezoning on the basis of an Irish company
3	expanding to create Irish jobs. I did not offer money. I did not ask Mr.
4	Dunlop to offer money. I did not ask. I was not asked for money nor did I
12:47:05 5	expect to be.
6	
7	I had the support of all parties before I met Mr. Dunlop. I did not ask him to
8	canvass me and I'm sure his own records will show that the only work he did for
9	me was on the best way to approach the Department of Transport.
12:47:05 10	
11	I have told you all of this before. I have also told you that I am a frequent
12	traveller yet you persist in writing to me with detailed questions setting
13	unreasonable dead lines. If you are going to have four year intervals between
14	letters then giving me two weeks to reply is unreasonable, nor is there any
12:47:06 15	point in apologising for calling me McGuinness if in the next letter you do the
16	same thing. I have now replied to all of your questions. There was no
17	corruption in what we did as I am sure any available record will verify. I
18	trust you will now be able to close this file. However, if you have further
19	questions please note that I do not expect to be back home in the island until
12:47:07 20	October/November. I will deal with any further correspondence then. Yours

23	P.S. Please note that I have already told you the individual identified is no
24	longer at that address nor am I in regular contact with him.

26	On the 24th of January 2006. At page 588. The Tribunal wrote to
27	Mr. McGuinness referring to previous correspondence and advising that the
28	Tribunal would proceed to a public hearing in relation to the matter on a date
29	to be fixed in the near future and that to assist the Tribunal with its
12:47:09 30	inquiries the members have determined that it would be necessary to review all

12:47:09 1	documentation relevant to the rezoning of the lands.
2	
3	And in that context, he was the writer directed therefore to advise that on
4	Wednesday 15th of February 2006 the members of the Tribunal would consider

18	The transcription is at 589. And it's re Cargobridge Dublin Airport. Your
19	letter 24th of January refers.

21	I regret that I have none of the material requested by you. All of the
22	Cargobridge correspondence was contained in one lever arch time. The file was
23	live when I left Neptune and the Department of Transport had not issued the
24	final documentation on the right-of-way, I left the file in my office. Tibbet
12:47:13 25	and Britton who bought Neptune in1997 have since been taken over by Excel, who
26	in turn have been bought by a German company. I have no idea where the
27	Cargobridge file is now.
28	
29	My submission in relation to this matter is that all of the political parties
12:47:13 30	agreed to support the rezoning of the motions having been proposed and seconded

12:47:13 1	before I met Mr. Dunlop. The level of support was clearly demonstrated when
2	the motion was voted on in March and September 1993. There was no need to
3	bribe anyone.

6	Limited and High Degree Construction Limited, C, Aer Turas limited and Rhodora
7	Limited, and D, Williams Air Freight and Ashbal Investments Limited.

9	3. He was asked to identify any other person or party involved with the
12:47:19 10	Cargobridge lands who had dealings with Mr. Frank Dunlop.
11	
12	4. Details of the interest held by him in the lands whether legal or
13	beneficial, and 5 details of his knowledge of and/or involvement with any
14	subsequent disposition or acquisition of the lands by or any corporate
12:47:20 15	structure or individual.
16	
17	He was requested to ensure that his narrative statement would be set out in
18	separate sections each dealings with each of the foregoing matters and any
19	other matters considered relevant by him.
12:47:20 20	
21	He was asked to give evidence in respect of the foregoing and any other matters
22	considered relevant by the Tribunal in respect of his prior involvement with
23	the matter.
24	
12:47:25 25	He was further advised that prior to the commencement of the public hearing he
26	would require, receive details of the evidence to be heard so that he would be
27	aware of it in advance.
28	
29	He was advised that his narrative statement as outlined above would form part
12:47:26 30	of the material furnished to affected persons in advance of the public hearing

12:47:26 1	and that the members of the Tribunal requested that his statement be delivered
2	to the Tribunal by close of business on Wednesday 15th of March or sooner.

12:47:30 25	of wrongdoing against me. I have been aware for some years that I am outside
26	your jurisdiction and cannot be compelled to co-operate, nevertheless in an
27	effort to assist the Tribunal I have replied to the best of my ability to the
28	Tribunal's inquiries. I am very disappointed that this course of the past six
29	weeks, I'm sorry I'll ready that again, I am very disappointed that in the
12:47:30 30	course of the past six years the Tribunal have not seen fit to advise me of

12:47:31 1	whatever false allegation Mr. Dunlop has made against me. I feel that you have
2	been corresponding with me under false pretences. My understanding of the law
3	is that any accused is entitled to know what the charges are.

6	and allow me to address this, the central issue. Please ensure that I receive
7	your letter, your reply before the 21st of August as shortly after that date I
8	will be embarking on a long planned trip and would like to seek legal advise
9	before I go, I will not, therefore, be in Dublin in September.
<i>12:47:43</i> 10	
11	I will be leaving the island shortly to settle my affairs in London. So please
12	forward your replies to me care of 160 Heene Road, Worthing, West Sussex, BN11
13	4PA, England.
14	
<i>12:47:44</i> 15	Please do not register your reply as I will be spending much of my time in
16	London and may not be there to receive it.
17	
18	My journey will take me through Far East, China, Australia, New Zealand and
19	hopefully South America. I will be gone almost a year but will be in contact
12:47:45 20	with the above address from time to time if there is any further
21	correspondence.
22	
23	I look forward to receiving your reply before the 21st of August.
24	
12:47:45 25	Again, a letter was received on the 28th of July at 2017.
26	
27	In the following terms.
28	
29	Dear Sirs, I have now had an opportunity to study some of the correspondence
12:47:46 30	you have sent me. I note that there is an order from the Tribunal requiring me

12:47:46 1	to make discovery under oath. I do not believe I am subject to orders from the
2	Tribunal and I have already replied to those questions.
3	
4	However, I do not wish to be discourteous to the Tribunal, so please forward a
12:47:46 5	copy form 10 A appendix C which is not readily available over here and I will
6	make discovery on oath as requested. Please ensure that the form reaches me at

12	the Irish Times dated 24th of July. I am appalled that despite being in
13	correspondence with the Tribunal for six years hear or read is in the national
14	press. Why was the I not made aware of these allegations? How were they
<i>12:47:48</i> 15	leaked to the press? What does the Tribunal intend to do about this? I will
16	deal with these false allegations shortly but welcome an immediate reply from
17	the Tribunal as to how they intend to deal with this matter and further
18	correspondence.
19	
12:47:48 20	Yours faithfully.

22	That letter was responded to on the 28th of July 2006 in some detail. And
23	Mr. McGuinness was advised by the Tribunal that it was not the source of the
24	article in the Irish Times. He was further advised that it would appear that
12:47:49 25	Mr. Cullen had access to portion of the circulated brief, each witness when
26	they came to give evidence would be asked if they breached the injunction
27	contained in the Tribunal's correspondence that they were not to disclose to
28	others the circulated brief.

2	Mr. McGuinness writes to the Tribunal again referring to the Paul Cullen
3	article in the Irish Times.

7	that the Tribunal have withheld from him for over six years. He now asks the
8	Tribunal to vindicate his good name and to protect it from unjust attack as it
9	was required to do under the article 43.2 of the Constitution. He says that

11	release this reply to the media and he awaited our urgent reply.

13	operated aircraft. Pat Cousins was MD.

<i>12:48:14</i> 15	D. Ashbal was an Irish company set up to hold its portion of the lands.
16	
17	At 2010 he continues. Williams Air Freight was an air transport warehousing
18	and distribution company. It's MD was Stephen Fitzgerald.
19	
12:48:15 20	3. Pat Cousins and Stephen Fitzgerald were the only other people involved with
21	the Cargobridge lands who met Frank Dunlop.
22	
23	4. Neptune Freight owned eight acres. I owned 62 percent of Neptune Freight.
24	I had no personal interest in the lands.

26	5. Abervanta sold its lands to High Degree Construction. Other than to answer
27	questions regarding rights- of- way etc. I had no other involvement.
28	
29	Neptune Freight was sold as a going concern to Tibbet & Britten in 1997. The
